The 34<sup>th</sup> AGM of the Company will be conducted virtual through **live streaming** and online remote voting via the Remote Participation and Voting Facilities ("**RPV**") via TIIH Online provided by Tricor Investor & Issuing House Services Sdn Bhd via its website at https://tiih.online.

#### **GENERAL MEETING RECORD OF DEPOSITORS**

For the purposes of determining a member who shall be entitled to attend the 34<sup>th</sup> AGM, the Company shall be requesting a General Meeting Record of Depositors as at 25 May 2023 ("General Meeting ROD"). Members whose names appear in the General Meeting ROD shall be entitled to attend, participate, speak and vote at the 34<sup>th</sup> AGM or appoint proxies or corporate representatives to attend and/or vote on the members' behalf.

#### REMOTE PARTICIPATION AND VOTING FACILITIES ("RPV")

Shareholders or proxies are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 34<sup>th</sup> AGM using RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <a href="https://tiih.online">https://tiih.online</a>.

A shareholder who has appointed a proxy(ies) or attorney(s) or authorised representative(s) to participate at this 34<sup>th</sup> AGM via RPV must request his/her proxy(ies) or attorney or authorised representative(s) to register himself/herself for RPV at TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>. Please refer to the Procedures for RPV section as set out below for further information.

As the 34<sup>th</sup> AGM is a virtual meeting, shareholders who are unable to participate in this 34<sup>th</sup> AGM may appoint the Chairperson of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

### **PROCEDURES FOR RPV**

Shareholders/proxies/authorised representatives/attorneys who wish to participate at the 34<sup>th</sup> AGM remotely using the RPV facilities are required to follow the requirements and procedures as summarised below:-

You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.</li> </ul>

Submit your request for RPV	<ul> <li>Registration is open from Friday, 28 April 2023 until such time before voting session ends at the 34<sup>th</sup> AGM on Tuesday, 6 June 2023.</li> <li>Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 34<sup>th</sup> AGM to ascertain their eligibility to participate in the 34<sup>th</sup> AGM using the RPV facilities.</li> <li>Login with your user ID and password and select the corporate event: "(REGISTRATION) LANDMARKS BERHAD 34<sup>TH</sup> AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select "Register for Remote Participation and Voting".</li> <li>Review your registration and proceed to register.</li> <li>TIIH Online system will send an e-mail to notify that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the General Meeting ROD as at 25 May 2023, TIIH Online system will send you an e-mail on or after 4 June 2023 to approve or reject your registration for remote participation.</li> <li>(Note: Please allow sufficient time for the approval of new user of TIIH Online as well as registration for the RPV.)</li> </ul>

d.	Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) LANDMARKS BERHAD 34<sup>TH</sup> AGM" to engage in the proceedings of the 34<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairperson/Board of Directors ("Board"), you may use the Query Box to transmit your question. The Chairperson/Board will endeavor to respond to questions submitted by remote participants during the 34<sup>th</sup> AGM. If there is time constraint, the responses will be published in the Corporate website earliest possible, after the meeting.</li> </ul>

Online remote voting	<ul> <li>Voting session commences from 10.00 a.m. on Tuesday, 6 June 2023 until a time when the Chairperson announces the completion of the voting session of the 34<sup>th</sup> AGM.</li> <li>Select the corporate event: "(REMOTE VOTING) LANDMARKS BERHAD 34<sup>TH</sup> AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>
f.	End of remote participation	Upon the announcement by the Chairperson on the closure of the 34 <sup>th</sup> AGM, the live streaming will end.

#### Note to users of the RPV facilities:

- 1. Should your application to join the 34<sup>th</sup>AGM be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

#### APPOINTMENT OF PROXY OR ATTORNEY OR AUTHORISED REPRESENTATIVE

Shareholders who appoint proxy(ies) to participate via RPV at the 34<sup>th</sup> AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor not later than **Sunday, 4 June 2023 at 10.00 a.m.** 

The appointment of a proxy may be made in a hard copy form or by electronic means in the following manner:

#### (i) In hard copy form

### (ii) By electronic form

The proxy form can be submitted electronically with the Share Registrar of the Company via TIIH Online at <a href="https://tiih.online">https://tiih.online</a>. Kindly refer to the Procedure for Electronic Submission of Proxy Form section as set out below for further information.

Please ensure ALL the particulars as required in the proxy form are completed, signed and dated accordingly.

Any authority pursuant to which such an appointment is made by a power of attorney must be deposited with the Share Registrar of the Company, Tricor Investor & Issuing House Services Sdn. Bhd. at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia or alternatively, the Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, Malaysia not later than **Sunday**, **4 June 2023 at 10.00 a.m.** to participate via RPV in the 34<sup>th</sup> AGM. A copy of the power of attorney may be accepted provided that it is certified notarially and/or in accordance with the applicable legal requirements in the relevant jurisdiction in which it is executed.

For a corporate member who has appointed a representative, please deposit the **ORIGINAL** certificate of appointment with the Share Registrar of the Company, Tricor Investor & Issuing House Services Sdn. The certificate of appointment should be executed in the following manner:

(i) If the corporate member has a common seal, the certificate of appointment should be executed under seal in accordance with the constitution of the corporate member.

- (ii) If the corporate member does not have a common seal, the certificate of appointment should be affixed with the rubber stamp of the corporate member (if any) and executed by:
  - (a) at least two (2) authorised officers, one of whom shall be a director; or
  - (b) any director and/or authorised officers in accordance with the laws of the country under which the corporate member is incorporated.

Insert your CDS account number and indicate the number of shares for your proxy(ies) to vote on your behalf.</li> <li>Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint the Chairperson as your proxy.</li> <li>Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide your vote.</li> <li>Review and confirm your proxy(ies) appointment.</li> <li>Print the proxy form for your record.</li> </ul>	
ii. Steps for corporation or institutional shareholders		
a. Register as a User with TIIH Online	<ul> <li>Access TIIH Online at <a href="https://tiih.online">https://tiih.online</a>.</li> <li>Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects the "Create Account by Representative of Corporate Holder".</li> <li>Complete the registration form and upload the required documents.</li> <li>Registration will be verified, and you will be notified by e-mail within one (1) to two (2) working days.</li> <li>Proceed to activate your account with the temporary password given in the e-mail and re-set your own password.</li> </ul>

The voting at the 34<sup>th</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor as

Poll Administrator to conduct the poll by way of electronic voting (e-voting).

Shareholders or proxy(ies) or corporate representative(s) or attorney(s) can proceed to vote on the resolutions at any time from the commencement of the 34<sup>th</sup> AGM at **10.00 a.m.** on **Tuesday, 6 June 2023** but before the end of the voting session which will be announced by the Chairperson of the meeting. Kindly refer to item (e) of the above Procedures for RPV for guidance on how to vote remotely

via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

Upon completion of the voting session for the 34<sup>th</sup> AGM, the Scrutineers will verify and announce the poll results followed by the Chairperson's declaration whether the resolutions are duly passed.
