GENERAL MEETING ARRANGEMENTS

As the COVID-19 situation in Malaysia is constantly evolving, we may be required to change AGM arrangements at short notice and will notify you of these changes.

CORONAVIRUS DISEASE ("COVID-19") PANDEMIC

In view of the COVID-19 health concerns and to safeguard the wellbeing of Shareholders, the 32nd Annual General Meeting ("32nd AGM") will be conducted virtually through live streaming and online voting using the Remote Participation and Voting ("RPV") facility from the Broadcast Venue. Therefore, there will not be a physical meeting venue for Shareholders to participate the AGM in person, as we take every necessary precaution to minimise the risk of COVID-19 infections.

The above arrangement is line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission of Malaysia, which provides guidance for listed issuers to conduct fully virtual general meeting, without a physical meeting venue, after the Movement Control Order (MCO) is lifted.

The Broadcast Venue is strictly for the purpose of compliance with Section 327(2) of the Companies Act 2016 and Clause 15.4 of the Company's Constitution which stipulated that a general meeting may be held at more than one venue, using any technology or method that enables the members of the Company to participate and to exercise the members' right to speak and vote at the general meeting and the Chairperson shall be present at the main venue of the AGM.

This is also in line with Practice 12.3 of the Malaysian Code on Corporate Governance, by conducting a fully virtual AGM, this would facilitate greater shareholder participation as it facilitates electronic voting and remote shareholders' participation.

With the RPV Facility, you may exercise your right as a Shareholder of the Company to participate (including to pose questions to the Board of Directors of the Company) and vote at the AGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the AGM.

Shareholders should not be physically present and **WILL NOT BE ALLOWED** entry to the Broadcast Venue during the AGM. Any Shareholders who turn up at the Broadcast Venue would be requested to leave the venue politely.

REMOTE PARTICIPATION AND VOTING FACILITY ("RPV FACILITY")

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 32nd AGM using RPV Facility provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its **TIIH Online** website at <u>https://tiih.online</u>.

Shareholders who appoint proxies to participate via RPV Facility in the 32nd AGM must ensure that the duly executed proxy forms are deposited in a hard copy form or by electronic means to Tricor no later than **10.00 a.m., Monday, 21 June 2021.**

Corporate representatives of corporate members who wish to participate at the 32nd AGM must deposit their original certificate of appointment of corporate representative to Tricor not later than **10.00 a.m., Monday, 21 June 2021**.

Nominee Company [whose beneficiary of the shares in its Central Depository System (CDS) account] who wishes to participate at the 32nd AGM via RPV Facility must deposit its proxy form in a hard copy form or by electronic means to Tricor not later than **10.00 a.m.**, **Monday**, **21 June 2021**.

Attorneys appointed by power of attorney who wish to participate at the 32nd AGM must deposit their power of attorney with Tricor not later than **10.00 a.m., Monday, 21 June 2021**.

A shareholder who has appointed a proxy or attorney or authorised representative to attend, participate, speak and vote at this 32rd AGM via RPV Facility must request his/her proxy or attorney or authorised representative to register himself/herself for RPV Facility at TIIH Online website at <u>https://tiih.online_no later than 10.00 a.m., Monday, 21 June 2021.</u>

As the 32nd AGM is a fully virtual AGM, shareholders who are unable to participate in this AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

Please note that the Company shall deem that shareholders have no objection to use the provision in the Proxy Form which has designated the Chairman of the meeting as the authorised person to vote on behalf of shareholders until further instructions are received. The appointed Poll Administrator of this AGM shall be notified of such arrangement accordingly.

ENTITLEMENTS TO ATTEND, SPEAK AND VOTE

In respect of deposited securities, only Shareholders whose names appear on the Record of Depositors on 14 June 2021 (General Meeting Record of Depositors) shall be eligible to attend, participate, speak and/or vote at the meeting via RPV facility.

PROCEDURES FOR RPV

Please read and follow the procedures below to engage in remote participation through live streaming and online remote voting at the 32nd AGM using the RPV facility:

If you are already a user with TIIH Online, you are not required to register again. You will receive an e-mail to notify you that the RPV Facility is available for registration at TIIH Online.

System will send an e-mail to notify that your registration for the RPV Facility is received and will be verified. After verification of your registration against the General Meeting's Record of Depositors as at 14 June 2021, the system will send you an e-mail after 21 June 2021 to approve or reject your registration for the RPV Facility.

(c)	Login to TIIH Online	 Login with your user ID and password for remote participation at the 32nd AGM at any time from 9.00 a.m., i.e. 1 hour before the commencement of the 32nd AGM at 10.00 a.m., Wednesday, 23 June 2021.
(d)	Participate through live- streaming	 Select the corporate event: "(LIVE STREAM MEETING) LB 32ND AGM" to engage in the proceedings of the 32rd AGM remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavor to respond to questions submitted by remote participants during the 32rd AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.

(e)	Online remote voting	 Voting session commences from 10.00 a.m., Wednesday, 23 June 2021 until a time when the Chairman announces the completion of the voting session at the 32rd AGM broadcast venue. Select the corporate event: "(REMOTE VOTING) LB 32ND AGM" or if you are on the live stream meeting page you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
(f)	End of remote participation	• Upon the announcement by the Chairman of the meeting on the closure of the 32 nd AGM, the Live Streaming will end.

Note to users of the RPV facility:

- 1. Should your registration to join the 32nd AGM be approved, the system will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

PROXY

Since the 32nd AGM will be conducted virtually, a Shareholder can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy. POLL VOTING

The voting at the 32rd AGM will be conducted by poll in accordance with Paragraph 8.29A of Main Market Listing Requirements of Bursa Malaysia Securities Berhad. The Company has appointed Tricor Investor & Issuing House Services Sdn Bhd as Poll Administrator to conduct the poll by way of electronic means and Asia Securities Sdn Bhd as Scrutineers to verify the poll results.

Shareholders can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and **submit your votes at any time from the commencement of the 32nd AGM at 10.00 a.m.** Kindly refer to item (e) of the Remote Participation and Voting for guidance on how to vote remotely from TIIH Online website at <u>https://tiih.online</u>. The Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
